You May Be Able to Get Supplemental Security Income (SSI)

You may be able to get SSI if your resources (the things you own) are worth no more than \$2,000 for a person or \$3,000 for a married couple living together. We don't count everything you own when we decide if you can get SSI. For example, we don't count a house.

Surviving the Loss of a Spouse - AG

The period of your grief will vary according to the nature of your relationship with your spouse and how suddenly or prolonged the death of your spouse happened to be. Usually, the more sudden your loss, the longer your grief since you had no time to prepare for it. If your spouse dies suddenly from natural causes, it may take 2 years to recover.
